David Lowe, President and General Manager of KVIE announced its Landmark television event with Ken Burns coming in September 2017, an 18 hour film being aired over 10 days showcasing the Vietnam War with perspective from North Vietnamese Soldiers, Refugees, and a West Point Cadet; thanked the Board for its continued support.
